HIGH JINKS RALLYE EXPERIENCE THE LANDSCAPE

Friday, Saturday, Sunday October 11, 12, and 13, 2019 SOPHISTICATION WITH A DASH OF FUN AUTHENTICITY, ORGINALITY, PRESERVATION IN A WELCOMING ATMOSPHERE

EVENT High Jinks Rallye – Experience the Landscape, hereinafter referred to as (HJR ETL), and is a competitive event for authentic vintage and historic cars which can broadly be described as street-legal, built in or before 1974. It is a "Road Rally" style event, where cars will run on the open road on a pre-determined route. (HJR ETL) is one event within an overall event known as *CHATTANOOGA Speed Sport Style*, hereinafter referred to as (C SSS).

(HJR ETL) will start and finish on the property located at 801 Pine Street Chattanooga, Tennessee 37402 on October 11, 12, and 13, 2019 and yearly thereafter on the second full weekend of October. The event is organized by *CHATTANOOGA Speed Sport Style*, LLC and is open to spectators who will have purchased the appropriate credentials to gain entry.

This (HJR ETL) portion of the event will be limited to 30 cars.

ENTRANT/DRIVER LICENSING AND INSURANCE Driver is required to show proof of both a valid Driver's License and Liability Insurance. Tennessee law requires minimum levels of \$25,000 per person, \$50,000 per accident. Uninsured Motorist Coverage is also required. Rally vehicles must be licensed for street use. A copy of your Vehicle Registration must be presented with your Rally Application. Each participant, including Driver and Navigator, shall sign a liability waiver as a condition of entry.

Please note that CHATTANOOGA Speed Sport Style, LLC will provide limited event insurance to cover only Driver, Navigator, Spectator, Event Officer and Staff liability, and does not include any coverage for Entrants', Drivers' and Navigators' cars or equipment, or damage to CHATTANOOGA Speed Sport Style, LLC event footprint properties along the route. Drivers and Navigators are encouraged to secure additional and appropriate Personal, Medical and Collision Damage Insurance.

Crew support packages must be strictly limited and individual requests will be reviewed prior to entry acceptance. Only one Crew Package per Entry is available.

VEHICLE REQUIREMENTS All vehicles must be "street legal", registered, fully operational, capable of completing the road course, and are required to present a neat and finished appearance, with no obvious body damage. Cars that do not meet this standard in keeping with the spirit of the event, in the sole determination of the organizer, will not be permitted to compete. If it is necessary to substitute an already accepted car, the Eligibility Committee must approve the proposed substitute car. Substitutions of non-eligible cars, in the spirit of the event, will not be permitted.

Seat belts are encouraged for all cars and Drivers and Navigators should be appropriately dressed for such a "driving" event. Similarly, the installation of a fire extinguisher is encouraged. In general, advertising on cars is discouraged. On "race cars", only advertising which duplicates the appearance of the cars as originally raced in period is preferred. Current advertising must be small and tasteful and will be permitted only on the sides of race cars and beneath a line from the top of the front fender opening to the top of the rear fender opening. The acceptance of this advertising will be at the sole discretion of the (HJR ETL) Administrator

Further, the (HJR ETL) Administrator reserves the right to admit or deny the entry of any particular vehicle if they decide it is in the best interests of the event. Such decisions are final and cannot be appealed or challenged.

APPLICATION FOR ENTRY INFORMATION

ENTRY POLICIES The Application for Entry may be downloaded from the event website <u>www.speedsportstyle.com</u> and must be sent to the official address listed in the application. ALL APPLICATIONS FOR ENTRY MUST BE RECEIVED BY August 10 of the event year. Entries must be limited due to the nature of the event and the amount of time required for all cars to complete the programmed course. The Administrator will accept or reject any Application for Entry to ensure that a broad range of appropriate cars can compete. The Administrator may, at their sole discretion, maintain a "waiting list." Cars may be added from this list to replace accepted entries that are unable to participate.

The decision to accept or reject any car and/or Driver and Navigator is solely that of the Administrator, and their decision cannot be challenged or appealed. All Applications for Entry will receive a reply, accepting or rejecting the entry (and its addition to a waiting list, if appropriate). The full entry fee will be due with the Application for Entry, as will a recent 4 x 6 inch color original photograph (no color copies or discs). No "For Sale" or other signage, displays or illustrations will be allowed on or near the entry except that which will be provided by the event organizer.

Submission of an Application for Entry for (HJR ETL) shall be considered as an implicit undertaking by the Entrant that he or she he is familiar with and undertakes to comply with and ensure compliance with the contents of the (HJR ETL) Regulations, and any other rules or regulations under which the (HJR ETL) and other (C SSS) events may be run. Further, the Entrant agrees that he or she recognizes (HJR ETL) as the sole competent jurisdiction, subject to any Rights of Appeal, and that he or she thus undertakes not to submit suits to arbitrators or other jurisdictions on the basis of circumstances deriving from the organization of the event and the running of the (HJR ETL) itself; and that he or she relieves (HJR ETL), (C SSS), the Organizers, the Administrator and other Officials and Staff from any third-party liability for injury and damage suffered by himself or herself as Entrant, or by his or her Driver and Navigator, Employees and property. Drivers and Navigators sign waivers to this effect.

SPORTSMANSHIP, TIMING AND PROTEST PROCEDURE All Drivers and Navigators will be expected to compete with the highest level of sportsmanship, with due regard for themselves, their fellow entrants, their cars, and officials. Any unsportsmanlike and/or dangerous conduct will be dealt with by the (HJR ETL) Rallye Master, whose decision as to appropriate action required (including any penalties or exclusions), will be final. Drivers and Navigators are expected to observe and obey all traffic laws, and any infraction of which may be grounds for expulsion from the event. At the conclusion of each day's course, all protests will be made to the (HJR ETL) Administrator. He will consult the Driver and Navigator involved to resolve any protests, and his decision will be final.

RESULTS AND AWARDS Any timing and scoring will be provided by the Official Scorer. The Official Scorer will issue Official Results, which will be the basis for all awards.
